### FORUM A - THURSDAY MORNING

### WHAT'S NEXT FOR YOU? A LOOK THROUGH THE LENS OF A FUTURIST Jesse Hirsh

### FORUM B - THURSDAY AFTERNOON

### TRUMP – THE GREAT DISRUPTOR?

**DR. JANICE STEIN** MUNK SCHOOL OF GLOBAL AFFAIRS, UNIVERSITY OF TORONTO

Trump is trying to disrupt the liberal international order that the United States put in place over decades. This was not supposed to happen. Why is it happening and how disruptive is Trump? Janice Stein will look ahead at the dangers and opportunities in an age of disruption and look at the consequences for institutional investors who have to navigate these choppy waters.

Stein is the Belzberg Professor of Conflict Management in the Department of Political Science and the Founding Director of the Munk School for Global Affairs at the University of Toronto. She is a Fellow of the Royal Society of Canada and an Honorary Foreign Member of the American Academy of Arts and Sciences.

She is the co-author, with Eugene Lang, of the prize-winning work, *The Unexpected War: Canada in Kandahar*, and her most recent book is *Diplomacy in the Digital Age*. Professor Stein was the Massey Lecturer in 2001, and a Trudeau Fellow. She is a member of the Order of Canada and the Order of Ontario. She has provided commentary for networks such as CBC, CTV, TVO and CNN, and columns and comment for *The Globe and Mail* and *The National Post*.

### FORUM C - FRIDAY MORNING

### OVERCOMING DISRUPTION – AN ATLANTIC PERSPECTIVE DR. Wade Locke

MEMORIAL UNIVERSITY OF NEWFOUNDLAND

Disruption and challenges are not new to Newfoundland and Labrador. With the recent downturn in oil prices, the large debt facing the province, an aging demographic, as well as the pending completion of the Muskrat Falls mega-project... Newfoundlanders know that there are no smooth waters ahead, but instead, rough seas that need to be navigated properly.

Dr. Locke will focus on the lessons learned from these issues and will give his thoughts on some concepts to help normalize disruption. He will also shed light on how these variables relate specifically to Newfoundland economy, and the Atlantic economy in general.

Dr. Wade Locke is a Full Professor of Economics at Memorial University of Newfoundland and is currently the Academic Head for the Department of Economics, Memorial University. He specializes in the Newfoundland and Labrador economy, resource economics, public finance, public policy, innovation indicators, productivity, economic impact assessment and cost-benefit analysis.

### FORUM D - FRIDAY MORNING

### **DISRUPTIVE INNOVATION IN HEALTHCARE**

DR. BRIAN GOLDMAN EMERGENCY ROOM PHYSICIAN, BESTSELLING AUTHOR & MEDICAL WATCHDOG

Dr. Goldman's style is earnest, heartfelt and sincere. He has a passion for compassion and he makes complex medical issues digestible for audiences by personalizing medicine and the human frailties of his profession. He is unafraid to address tough or controversial issues head on in a comprehensive way.

Dr. Goldman is a highly regarded emergency physician at Mount Sinai Hospital in Toronto. He is also the host of the CBC award-winning radio show White Coat, Black Art, where he takes listeners behind the scenes of hospitals and doctor's offices.

In his bestselling book, The Night Shift: Real Life in the ER, Dr. Goldman takes readers through giddying heights and crashing lows as he works through a typical night shift in one of Canada's busiest ERs. His second book, *The Secret Language of Doctors*, is a biting look at medical slang. It cracks the coded words doctors use in hospital elevators and hallways that reveal what the doctor really thinks about your mother's obesity, your grandfather's dementia or her colleague's competence.

#### Session 1

### DISABILITY MANAGEMENT: A PLAN SPONSOR CASE STUDY

SUSAN BELMORE-VERMES, HEALTH ASSOCIATION NOVA SCOTIA GODFREY JERRY, MANULIFE

Atlantic Canada's underlying demographics, with a rapidly aging population and high rates of chronic disease, have contributed to disability plan costs amongst the highest in the country. Compounding these pressures, access to care is impacting the workforce as a result of physician shortages, rising surgery wait times and access to mental health services. This session will provide an Atlantic Canadian perspective on disability plan management challenges and strategies, and will highlight key learnings from a large Trusteed association plan, representing public and private sector health care employees.

### SESSION 2

# THE TRUMP EFFECT – WHAT DOES IT MEAN TO EQUITY MARKETS AND LOW-VOLATILITY INVESTING?

The start of his administration has led to some interesting movement in the equity markets. Has the arrival of a disruptive president impacted low volatility investing?

From the integration of wearable technologies and data analytics to the use of social media and online wellness tools, the Canadian digital health landscape is growing exponentially. The session will profile an employer case study in the use of digital health technologies to support wellness across a diverse workforce, and will offer a perspective on the future of digital health applications for the workplace.

### SESSION 4 A BRAVE NEW WORLD: A PLAN SPONSOR'S UNCONVENTIONAL APPROACH TO ASSET ALLOCATION JONATHAN CROFT, MERCER TERRY TAYLOR, TRIO BENEFITS

In the continuing environment of low interest rates, it is increasingly difficult for pension funds to realize a satisfactory annual investment return while also effectively managing risk. This session outlines how a medium-sized fund employed non-traditional investment strategies to improve its investment performance and enhance its risk management.

### SESSION 5

ADDRESSING THE DRUG MIX – STRATEGIES TO COMBAT LOW VALUE SPEND John Herbert, Express Scripts Canada Barbara Martinez, The Great-West Life Assurance Company Leanne MacFarlane, Managed Health Care Services Inc.

Making room in the health plan budget for expensive new specialty drug therapies increasingly requires plan sponsors to look for savings opportunities within their existing plans. While the widespread adoption of mandatory generic substitution in recent years has helped mitigate the pace of increase, new strategies are required to ensure longer-term benefit plan sustainability. In this session, a panel of experts from the pharmacy benefit management, insurance and pharmacy sectors will discuss the issue of Drug Mix Waste and strategies to combat low value drug spend.

#### SESSION 6

### THE DECUMULATION DILEMMA: PLAN MEMBERS HAVE MADE IT TO RETIREMENT, WHAT'S THE NEXT STEP?

IAN CLAVEAU, INDUSTRIAL ALLIANCE

Plan sponsors assist their members in accumulating assets and benefits towards retirement, but what happens when the plan member actually retires? Plan providers, sponsors and regulators are starting to consider what might be necessary to promote successful outcomes after retirement.

Whether the benefits come from a Defined Benefit Plan or Defined Contribution plan, the challenges are the same: what can Plan Sponsors do to help their retirees, and what is the Plan Sponsor's role and responsibility?

Join Ian Claveau as he explores the options available today, and contrasts tools that Plan Sponsors historically consider versus things that plan sponsors should be considering as they work to assisting the plan member.

### SESSION 7

PHARMACOGENETICS: OPPORTUNITY OR THREAT? ROD ZBEDIAK, STEWART MCKELVEY ZAHRA SAKKEJHA, PERSONALIZED PRESCRIBING NED POJSKIC, GREEN SHIELD CANADA

Advancements in genetic testing offer the promise of new tools to help manage disease and treatment options, including optimized drug therapies. Personal medicine creates both potential opportunities and challenges for employee benefit plans. Notwithstanding passage of Bill S-201, the Genetic Non-Discrimination Act, by the House of Commons, it will take time before the Supreme Court completes its constitutionality reference of the legislation. The legislation may have serious implications for individuals, employers and insurance companies. This session will offer a panel discussion featuring speakers representing the insurance, legal and genetic testing communities and will no doubt raise some very thoughtful considerations for all stakeholders.

### SESSION 8

### CPBI APPEALS COURT IN SESSION: THE LEGAL UPDATE COLETTE BARBATI, MORNEAU SHEPELL JASON MCQUAID, EMERA INC. "JUDGE JUDY" TBC

From the Skinner Ruling on Medical Marijuana to the Ontario Privacy Commissioner's ruling on Access to Information, several recent court decisions have changed the landscape for Employers and Employees across the country. Join us as "Judge Judy" listens to several of these cases being "re-tried" in the CPBI Appeals Court. Judge Judy is a no-nonsense arbiter, tough and fair. And she tends to rule the same way the courts actually did.

Judge Judy will hear from a lawyer on each side, and will then give her ruling. This will be a fun and unique look at how the court rulings were made, and the future impact of these rulings on plan sponsors.
